Japan, Switzerland, Kenya, Suriname, Thailand, India, Grenada and France - just a few of the

countries this jetsetter has traveled. But contrary to what many may initially think, these sojourns

are not being made to bask in the cultural offerings, tourist attractions, or the shopping

experiences these countries are known for; they are all part of the work of a woman leading

Jamaica's charge in a global environmental issue- Ozone Layer Protection.

As National Ozone Officer, Nicol Walker, is head of the National Ozone Unit which is housed at

the National Environment and Planning Agency. She is THE mover and shaker ensuring Jamaica

along with 197 other countries reduces its production, importation and use of substances that

destroy the ozone layer.

"It's a huge responsibility because I am responsible for ensuring Jamaica meets its obligations

under the Montreal Protocol on Substances that Deplete the Ozone Layer, so the buck really

stops with me. While Jamaica does not produce ozone depleting substances (ODS), we have

agreed to phase out the amounts we import. By 2040, all ODS should be eliminated."

Jamaica has helped to make the Montreal Protocol one of the most successful environmental

agreements ever signed. The country has also been recognized and received awards for our

efforts.

"We (Jamaica) have a lot to be proud of. Through the work of the Unit, the country was

successful in phasing out a dangerous ODS in 2006. Chloroflourocarbons (CFCs) were....

Jamaica was able to completely phase out its importation four years ahead of the Montreal

Protocol's schedule which was January 1 2010. The country was also able to phase out Halons in

2002, and two other ODS in 2007."

In fact, Jamaica has been so successful in achieving its targets that the nation received the

'Montreal Protocol Exemplary Project Recognition' Award in 2007.

The Ozone Head admits that along with the good, there are challenges which she has had to

The Ozone Unit manages projects and takes part in a number of activities geared towards

protecting the ozone layer. These activities include training industry professionals on alternatives

to ODS, how to identify, store, and dispose them. The Unit also helps companies retrofit their

machinery to comply with ozone friendly practices.

Walker, who is a graduate of the University of the West Indies had no plans to be in the Ozone

Unit. With an Undergraduate degree in Zoology and Botany, and a Postgraduate degree in

Zoology, she explains how she came to be involved in her current post.

"I first ended up at NEPA in 2003 managing a project on persistent organic pollutants. I

transitioned into the Ozone Unit in 2005 when the previous ozone officer was leaving. I had no

knowledge on the Ozone Layer protection at the time; zero, nada, zilch. Everything I learnt I

learnt on the job. It was a little overwhelming but we had a large team of people who helped to

get me up to speed."

Now, being more than proficient in the issues, this one-woman show who only has one project

assistant, has written remarks for Government Ministers, the Agency's CEO, conducted media

interviews, co-chaired international meetings, and made presentations to the island's tertiary

institutions and other groups.

"We really have contributed a lot to ozone layer protection, even though there is still a far way to

go. It's always a high when targets are achieved on time and under budget. It may not sound like

a lot, but it makes a world of a difference. On September 16, the world will celebrate

Her message for the nation.

"Play your part, and by that I mean, be open to alternatives to ODS. Let us not be stuck in the old

way of doing things. For consumers, protect yourself from sun exposure - wear your glasses,

sunscreen, hats, use your umbrellas, and wear long sleeved shirts and pants to protect your skin if

you are going to be in the sun for long periods of time."
