The Documentation Centre of the National Environment and Planning Agency is a Unit of the Public Education and Corporate communication Branch.

It is the National Focal Point (NFP) for INFOTERRA, the Global Environmental Information Exchange Network, designed and operated by the United Nations Environment Programme (UNEP).

It is also a member of the Science and Technology Information Network (STIN) which is a grouping of Special Libraries in the wider National Information Network System.

The library is a merger of the libraries of the Natural Resources Conservation Authority (NRCA) and the Town Planning Department (TPD).



THE COLLECTION



The collection is a special one and contains literature covering environmental and planning topics such as:

- Environmental law
- Global conventions
- Terrestrial and wetlands ecosystems
- Oceans and coastal areas
- Pollution and waste
- Policies, standards and guidelines prepared by the Natural Resources Conservation Authority /NEPA
- Urban plans prepared by the Town Planning Department(TPD)
- Development Orders prepared by TPD

THE CATALOGUE

Our catalogues are in electronic and card form. There are two electronic databases using UNESCO's WINISIS system. One covers environmental literature and the other is devoted to Environmental Impact Assessments (EIA's) prepared, on the request of NRCA/NEPA, for developments that have been lodged with the Agency. The planning documents are represented by a card catalogue.
