- 1. This Order may be cited as the Natural Resources (Montego Bay Marine Park) Order, 1992.
- 2. The area described in the First and Second Schedules shall con- First and stitute and be known as the Montego Bay Marine Park. Schedules.

## FIRST SCHEDULE

(Paragraph 2)

Area of the Montego Bay Marine Park

Commencing at a point referred to as "A" on the sketch plan reproduced in the Second Schedule which is at the high water mark on the northern shore with geographical co-ordinates which are latitude 18 degrees 30' 19" north, longitude 77 degrees 55' 00" west and situated along the old Main Road from Montego Bay to Ironshore, in the vicinity of Sangster International Airport runway; thence due north for approximately 1,247 feet to a point in the sea with geographical co-ordinates latitude 18 degrees 30' 30" north, longitude 77 degrees 55' 00" west; thence due west for approximately 3,038 feet to a point in the sea with geographical co-ordinates latitude 18 degrees 30' 30" north, longitude 77 degrees 55' 30" west, thence in a south-westerly direction for approximately 5,643 feet to a point in the sea referred to as "B" on the sketch plan, with geographical co-ordinates latitude 18 degrees 30' 00" north longitude 77 degrees 56' 20" west; thence due north for approximately 6,076 feet to a point in the sea with geographical co-ordinates latitude 18 degrees 29' 00" north, longitude 77 degrees 56' 20" west; thence in a south-westerly direction for approximately 14,583 feet to a point in the sea with geographical co-ordinates latitude 18 degrees 27' 13" north, longitude 77 degrees 58' 00" west, and referred to as "C" on the sketch plan; thence in a north-westerly direction for approximately 5,906 feet to a point in the sea with geographical co-ordinates latitude 18 degrees 27' 26" north, longitude 77 degrees 59' 00" west, thence due south from approximately 1,805 feet to a point at the high water mark on the shoreline situated in the Unity Hall area in the parish of St. James and having geographical co-ordinates latitude 18 degrees 27' 8" north, longitude 77 degrees 59' 00" west; thence along the high water mark in an easterly and northerly direction that is contiguous to the following areas: Unity Hall, Spring Garden, Reading, Bogue, Montego Freeport, Catherine Hall and Montego Bay thence back to the starting point ref and Montego Bay thence back to the starting point referred to as "A".
