2. The First Part of the Second Schedule to the Act is hereby amended by adding next after the words "Green-winged Teal—(Anas crecca)" the words "Pea Dove—(Zenaida aurita)".

THE WILD LIFE PROTECTION ACT

THE WILD LIFE PROTECTION (HUNTERS' RETURNS) (AMENDMENT) REGULATIONS, 2002

In exercise of the power conferred on the Natural Resources Conservation Authority by section 14 of the Wild Life Protection Act, the following Regulations are hereby made with the approval of the Minister:—

1. These Regulations may be cited as the Wild Life Protection (Hunters' Returns) (Amendment) Regulations, 2002 and shall be read and construed as one with the Wild Life Protection (Hunters' Returns) Regulations, 1999, hereinafter referred to as the principal Regulations.

2. Form A in the schedule to the principal Regulations is deleted and a new form substituted therefor—

HUNTER'S BIRD SHOOTING REPORT FORM

THIS FORM MUST BE COMPLETED AND RETURNED, ON OR BEFORE DECEMBER 31, FOLLOWING THE CLOSURE OF THE GAME BIRD SHOOTING SEASON THEREAFTER A LATE PROCESSING FEE WILL BE APPLIED AS FOLLOWS: JANUARY 1 TO MARCH 31—\$2,000.00; APRIL TO MAY 31—\$5,000.00; JUNE 1 TO AUGUST 15—\$10,000.00; FAILURE TO COMPLY WITH THE FOREGOING WILL RESULT IN THE DENIAL OF A HUNTER'S LICENCE FOR THE SUBSEQUENT SEASON. ALL RETURNS ARE EITHER TO BE MADE DIRECTLY TO THE NATURAL RESOURCES CONVERSATION AUTHORITY, 10 CALEDONIA AVENUE, KINGSTON 5, OR ARE TO BE SENT BY REGISTERED MAIL TO P O BOX 207, KINGSTON 5
